Editor Lori M. Campbell's <A Quest of her Own> is a compilation of essays broken up into four parts, each part addressing a specific type of female hero. These types include Pathfinders, Underestimated Overachievers, Show-Stealers, and Unwilling Do-Gooders. The introduction gives a clear explanation of how Campbell devised and defined the different categories in which she puts her heroines. The goal of the text is "to define the unique qualities of female heroism in literary fantasy from Tolkein's <Lord of the Rings> in the 1950s through the present." Another goal of the text is to give a feminist perspective on modern fantasy; a perspective which, according to the editor, is lacking. However, it is not unheard of, and Campbell and her authors draw from the few feminist readings of modern fantasy which do exist to inform their essays. It is important to note, however, that not all the essays focus on modern fantasy. The compilation uses several essays about much older texts, such as Thomas Mallory's <Le Morte Darthur> to serve as a framework for the textual interpretations of more contemporary writings. Interestingly, the essays include subject matter as modern as Brienne of Tarth from George R.R. Martin's <A Song of Ice and Fire> and Narcissa Malfoy of J.K. Rowling's Harry Potter novels.

There is also discussion of Saki's depictions of male-male relationships. Appendices offer primary source correspondence. The book contains one b&w photo of Saki.

<Shonda>, the Yiddish word for 'shame' or 'scandal,' also means the public exposure of scandalous information about the Jewish community. Author Leshner, himself an Orthodox Jew, is a lawyer who has written articles and a book on child abuse and the American family court system. In this book, he

analyzes cases of child sexual abuse in Orthodox Jewish communities that have been covered up by Jewish authorities internally rather than handled by the police and court system. He demonstrates how rabbis and community leaders have sided with alleged abusers against their victims, and how victims have been pressured not to turn to secular law enforcement. He also examines the role of rabbinic courts and the power of local Orthodox patrols in Orthodox Jewish communities, and makes suggestions for reform.

This is a collection of thirteen essays analyzing King's later work. The collection is divided into three groups: essays that focus on King's impact on popular culture, essays that focus on King's </The Dark Tower/> series, and essays that focus on King's output in the new twenty-first century. Edited by Patrick McAleer, co-chair of the Stephen King Area of the Popular Culture Association and Inver Hills Community College English teacher, and Michael A. Perry, and associate professor of English at Rockford University, Illinois, this book provides readers with critical examinations of King's work that has received less critical attention than the author's earlier work.

Author Stover himself used false documents to enlist in the US Coast Guard at age 14; he served for four years. In this book, he profiles people who enlisted in the US military at ages 11-16 and served in different branches of the military during the 20th century, including a 12-year-old boy who was decorated for his actions at Guadalcanal and a 13-year-old girl who was discovered and sent home from the European theater of WWII. The author conducted interviews with actual veterans, and their words and stories are grouped in thematic chapters on areas such as why they enlisted, how they pulled it off, surviving boot camp and the first assignment, young prisoners of war, and young women. B&w historical photos are included.
